INFORMATION ON THE PROCESSING OF PERSONAL DATA

The administrator of your data is DTA Customs Service sp. z o.o. with its registered office at Lipowa 1, in Smolec. At the same time, we would like to inform you that the Administrator has appointed a person who can be contacted in all matters regarding the processing of personal data and the use of rights related to the processing of personal data at the postal address of the Administrator's office or electronically via the e-mail address: rodo@dta.com.pl

Providing personal data is voluntary, but necessary to conclude and perform the contract.

The data provided by you may be processed for the purpose of: making customs declarations, concluding and performing specific contracts, e.g. forwarding, transport, storing shipments.

Your personal data will be stored for the duration of the service provided to you by the Administrator, as well as for the period of considering a possible complaint and until any claims are time-barred or the obligation to store data resulting from legal provisions expires, in particular the obligation to store customs, transport and accounting documents.

The legal basis for data processing is the necessity to fulfill the legal obligation incumbent on the Administrator (customs and tax regulations) and:

- Art. 6 sec. 1a Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 - consent,
- Art. 6 sec. 1b Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 - performance of the contract,
- Art. 6 sec. 1c Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 - processing is necessary to fulfill a legal obligation,
- Art. 6 sec. 1f Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 - legitimate interests pursued by the administrator.

Your data will not be shared with entities outside the European Economic Area (EEA) or any international organizations. They are also not subject to automated decision making, including profiling.


The personal data you provide will be made available to:

- companies cooperating with DTA Customs Service Sp. z o.o. in order to perform the ordered service,
- entities authorized to do so under the provisions of law.

You have the right to:

- request from the Administrator to access the processed personal data at any time,
- rectify personal data or limit the processing of such data,
- requests to transfer personal data to another Administrator,
- object to the processing of your personal data,
- demand the immediate removal of your personal data from the collections kept by the Administrator,
- lodge complaint to the supervisory body, ie the President of the Personal Data Protection Office, in the case of processing personal data in a manner that violates the provisions of generally applicable law.

The administrator makes every effort to ensure all physical, technical and organizational measures to protect personal data against accidental or deliberate destruction, accidental loss, alteration, unauthorized disclosure, use or access, in accordance with applicable regulations.
